MINUTES:

The Board reviewed and discussed the minutes of the Board of Directors meeting of May 5, 2010, Secretary Richardson moved to approve the minutes of the Board of Directors meeting of May 5, 2010 as corrected. Director Bird seconded the motion and the motion was carried unanimously.

TREASURER'S REPORT:

COMMITTEE REPORTS:

Personnel: The Board discussed the position of Site Manager. Director Bird seconded the motion and the motion was carried unanimously.

UNFINISHED BUSINESS:

- 1. Spalling Repairs: The Board discussed warranty work by CDI to be rescheduled on a specific date and time by AE Cloutier
- 2. Rear Spalling and Railings: The Board discussed several proposals on replacing the Railings and combined spalling work required. The matter was deferred pending owner input at the Association Informational and Open Forum meeting scheduled June 19, 2010.
- 3. Rain leaks: The Board discussed a proposal from Tory's Roofing to repair cuts to the roofing membrane. Treasurer Cai moved to accept the proposal from Tory's Roofing to repair the cuts to the roofing membrane for a total price of \$1500. Vice President Shah seconded the motion and the motion was carried unanimously. AE Cloutier was directed to have Tory's Roofing furnish a proposal for the entire roof with an estimate of the current useful life of the roof.
- 4. Refuse Service: The board discussed two contract proposals to provide refuse removal service from Roll-Offs Hawaii and Honolulu Disposal. <u>Vice President Shah moved to accept the contract proposal from Honolulu Disposal to provide refuse removal service for the total monthly rate of \$900.52. Treasurer Cai Seconded the motion and the motion was carried 4-1, with Director Bird opposed.</u>

NEW BUSINESS:

1. Recycling: The Board discussed the feasibility of a recycling program. The matter was deferred pending more research on options.
