Noting a quorum present, President Panalal called the meeting to order at

OPEN FORUM:

Owner Robert Urquhart addressed the Board regarding a bill in the amount of \$1823.18 that he paid for painting common areas on the Penthouse level.

The Board discussed reimbursing Owner Robert Urquhart for a bill that he paid to have common areas on the Penthouse level painted. <u>Director Harper moved to reimburse Robert Urquhart for the full amount of the bill.
