- 1. Rear Spalling and Railings: The Board discussed various aspects of the project draft contract with SSI, specifically the insurance coverage provided by of 1 to 2 million. Secretary Richardson moved to accept the insurance coverage provided by SSI, Vice president Shah seconded the motion and the motion was carried unanimously.
- 2. Roof Leaks Status: The Board discussed ongoing attempts to determine the source of leaks and solve the problem. A proposal from Beachside Roofing to patch visible holes was discussed. SM DiSante is working with Carlisle Inc to extend warranty if Beachside Roofing does the work.
- 3. Plumbing Inspections Proposal: The Board discussed purchasing a plumbing inspection for all units. The matter was deferred pending proposal
- 4. Smoke Detectors: The Board discussed purchasing and installing individual smoke detectors for all units. The matter was deferred pending proposal from SRG. AE Cloutier was directed to obtain proposal from City Mill.

## **NEW BUSINESS:**

1. 2012 Proposed Budget: The Board discussed a proposed budget and reserve analysis for 2012. President Panalal suggested that the maintenance fees be increased by 3%. <u>Director Harper moved to accept the proposed 2012 budget and reserve analysis with a 0% increase in maintenance fees and a monthly transfer of \$14,430 to the reserve account.
