<u>UNFINISHED BUSINESS:</u>

- 1. Rear Spalling and Railings: The Board discussed various aspects of the SSI project contract with JPB representative Jonathan Brandt. President Panalal signed the final AIA contract. Work is scheduled to commence February 29, 2012.
- 2. Plumbing Inspections: The Board discussed Aqua Flow Tech plumbing inspections. A letter has been mailed out to all owners informing them to schedule inspections with Aqua Flow Tech.
- 3. Roof Leaks Status: The Board discussed recent communications concerning roof leaks. A complete re-coating of the entire roof is scheduled to be completed before the end of February 2012. A 50% deposit has already been paid to Rainbow Roofing for the work and the issue of on-going leaks should be solved after the work is completed. The matter was deferred pending completion of re-roofing by Rainbow Roofing.

1. Elevator Contract: The Board discussed a proposed 5 year renewal contract from Shindler Elevator for elevator maintenance. <u>Director Harper moved to approve the proposal. Vice President Sha seconded the motion and the motion was carried unanimously.</u>
